1. About Us

THE SOUTHERN LIGHTS – TO NOTIO SELAS ASTIKI MI KERDOSKOPIKI ETAIREIA (hereinafter referred to as “**THE SOUTHERN LIGHTS**”) is a non-profit civil company based in the South of the Peloponnese, Greece, operating within an agroforestry farm environment.

The company is registered in the **General Registry of Commerce (GEMI)** under registration number **168604939000**.

THE SOUTHERN LIGHTS operates in accordance with the laws of the **Hellenic Republic**.

The mission of **THE SOUTHERN LIGHTS** is to spread knowledge, practical skills, and regenerative mindsets across all domains of human activity. This mission is pursued through workshops, networking initiatives, and the development of active, living examples of regenerative practices, in close collaboration with other organizations, public institutions, and ecological enterprises.

This website (the “**Site**”) is owned and operated by **THE SOUTHERN LIGHTS ASTIKI MI KERDOSKOPIKI ETAIREIA**, whose registered office is located in **Karyes, Lakonia Region, Greece**.

2. Terms and Conditions

2.1 General Provisions

2.1.1 Application of Terms and Conditions

Use of the Site constitutes acceptance of these Terms and Conditions. **THE SOUTHERN LIGHTS – TO NOTIO SELAS ASTIKI MI KERDOSKOPIKI ETAIREIA** (hereinafter referred to as “**THE SOUTHERN LIGHTS**”) reserves the right to amend these Terms and Conditions at any time without prior notice.

Users are responsible for reviewing these Terms and Conditions each time they access the Site. Continued use of the Site following any changes shall be deemed acceptance of the revised Terms and Conditions.

2.1.2 Availability

Access to the Site is permitted on a temporary basis. **THE SOUTHERN LIGHTS** reserves the right to withdraw, suspend, or modify the Site or any part of its content without prior notice.

2.2 Privacy

2.2.1 Processing of Personal Data

2.2.2 Statement of Intent

When you provide personal data to **THE SOUTHERN LIGHTS**, such data will be processed in accordance with applicable data protection laws, including but not limited to:

- the **General Data Protection Regulation (EU) 2016/679 (GDPR)**
- the **Greek Law 4624/2019** implementing the GDPR
- any other applicable Greek or European data protection legislation

In particular, **THE SOUTHERN LIGHTS** undertakes to:

- collect personal data lawfully, fairly, and transparently
- inform users about the purposes for which their data is collected and used
- keep personal data secure and protected against unauthorized access
- retain personal data only for as long as necessary for the purposes for which it was collected.

The types of personal data that may be collected through the Site include:

- Name
- Email address

- Postal address
- Telephone number
- Social media profile links (if voluntarily provided)
- Any additional information submitted through forms, questionnaires, or applications

THE SOUTHERN LIGHTS may collect some or all of this information depending on how users interact with the Site.

THE SOUTHERN LIGHTS will not send communications for marketing or informational purposes unless you have provided your explicit consent, where required by law.

2.2.3 Disclosure of Personal Data

THE SOUTHERN LIGHTS will treat personal data as confidential and will not disclose it to third parties without your consent, except where:

- disclosure is required or permitted by law
- disclosure is necessary for the operation of the Site or organizational activities
- third-party service providers are engaged to process data on behalf of **THE SOUTHERN LIGHTS** (for example, hosting services, data analysis tools, or email communication services).

In such cases, third-party processors are required to maintain appropriate security measures and process personal data in accordance with instructions provided by **THE SOUTHERN LIGHTS**.

Where third-party service providers are located outside the **European Economic Area (EEA)**, appropriate safeguards will be implemented in accordance with applicable data protection legislation.

2.2.4 Protection of Personal Data

THE SOUTHERN LIGHTS takes appropriate technical and organizational measures to protect personal data against unauthorized access, loss, misuse, or alteration.

Such measures may include physical, electronic, and administrative safeguards designed to ensure that personal data remains secure, accurate, and up to date. Personal data will be retained only for as long as reasonably necessary to fulfill the purposes for which it was collected.

While **THE SOUTHERN LIGHTS** implements appropriate security safeguards, transmission of information over the internet is not completely secure.

Accordingly, any transmission of personal data to the Site is undertaken at the user's own risk.

2.3 Cookies

Cookies are small text files that may be stored on your device when visiting websites to help websites function efficiently and understand user interactions.

- disclosure of relevant information to law enforcement authorities where required by law.

Failure to comply with these provisions constitutes a material breach of these Terms and Conditions.

2.5.1 Standards for Submitted Information
